## *Lady Takeko Kujō*

おほいなるものの力にひかれゆく  
吾が足あとのおぼつかなしや

Ōinaru mono no chikara ni hikareyuku  
Waga ashiato no obotsukanashi ya

Drawn ahead by a great power,  
My footprints grow ever faint.

SHINRAN SHŌNIN'S ENCOUNTER with Amida Buddha's Primal Vow changed his entire life. He had entered a world of embrace and thereupon sought to share that world with everyone through his teachings of Jōdo Shinshū. Shinran's teachings have resonated within the hearts and minds of nembutsu followers for the past 750 years. His religious heart continues to guide us to that world, and there our lives are changed forever as well.

Lady Takeko Kujō (1887-1924) also lived within that world of embrace. A direct descendant of Shinran, Takeko Ōtani was the daughter of Myōnyo Shōnin (1850-1903) the twenty-first Monshu of the Hongwanji and the younger sister of next Monshu, Kyōnyo Shōnin (Kōzui Ōtani).

Her father was a remarkable leader. He established the *gojikai* society to provide financial support to the dissemination of Shinran's teachings. He also founded the Greater Japan Buddhist Welfare Society Foundation, one of the first social welfare organizations in modern Japan. He built schools and orphanages. He saw the need for chaplaincy in prisons and in the military. Myōnyo was also instrumental in establishing overseas Hongwanji missions. He supported the founding of the Hongwanji Mission of Hawaii and the North American Buddhist Mission (later, the BCA). Her brother, Kōzui, was also famous for leading excursions that uncovered countless lost Buddhist treasures in Asia.

Takeko's life was also extraordinary. After her marriage to Baron Ryōchi Kujō, she dedicated her life to Jōdo Shinshū and the Hongwanji. She founded the Buddhist Women's Association (*Fujinkai*) to promote the status and contributions of Shin Buddhist women. She established the Asoka Hospital, one of Japan's first modern medical centers that is still operating today. She also built hospitals and started social welfare programs in other parts of Asia, directing most of her efforts to serving the poor and the sick.

Following the Great Kanto Earthquake of 1923, Lady Kujō went personally to the ruined city of Tokyo. There she worked tirelessly to care for the victims of that terrible disaster. Tragically, while working in one of Tokyo's poorer areas, she contracted an illness and died shortly thereafter.

Lady Takeko Kujō wrote many poems and hymns that expressed her trust in Amida's Primal Vow. Among them was the simple verse above, written in the face of the suffering of other people and her own illness. We get a sense here of the deep faith of this amazing person. Even one so strong and caring as Lady Kujō must have grown weary in her efforts to relieve the suffering of others. Yet, at the same time, she found herself embraced—lifted, as it were—by a "great power." Finding herself taken in and held by the compassionate heart of the Buddha of unhindered Light, the weight on her own heart began to lift and the heaviness of her steps gave way to a lightness and joy of being.

## The Experience of Helplessness: My Husband's Emergency Surgery

I am experiencing the second most awful kind of wait, the kind that takes place in a hospital waiting room during surgery on a family member. Of course the very most awful kind of wait is the kind experienced by the pre-op patient himself, lying on a gurney hungry, thirsty, anxious, bored, and often in pain, waiting with mounting impatience for the most enjoyable part of the surgical experience, which is being totally unconscious under anesthesia for a few merciful hours of it. At least that part is over for Bill, my husband, who should long since be fully anesthetized. The trouble is, they do not anesthetize the patient's spouse.

There is a heavily computerized desk in this waiting room. There are supposed to be kindly people sitting there who tell families when the patient is out of surgery and where they can go to see him and find out about the outcome. But there is nobody at that desk. It seems there never is after five o'clock, when emergency surgery tends to happen. So I have nobody to ask why although the surgery on my husband's broken kneecap was supposed to last about one hour, I have heard nothing for four. It's "only" putting a kneecap that has been broken in half back together again, but any surgery can go wrong, sometimes disastrously wrong. Every time the phone at the unmanned desk rings and goes unanswered, I envision the surgical team chanting the Tibetan Book of the Dead for Bill.

Just what is it about this wait that is so hard to take? I think it is the fact that there is nothing I can do. In the face of grave illness or serious injury like a broken kneecap in a man of 69, there is only so much any mere human being can do (and the greatest doctors will tell you so). Sometimes modern medicine wins, sometimes it loses, and in the end it always loses. The frailty of our bodies is, like so much of life, finally outside our control.

That is not to say that we should be fatalistic. The Buddhist law of karma teaches that we are responsible for the things we can control, such as our treatment of others, and that we should always do our best. But we live in—we are a part of—a great big complicated universe which we do not rule. That is why things keep happening that we do not wish to happen, no matter how rich or clever or powerful we think we are. That is intolerable as long as we think this suffering little self is all that matters. Amida is there to help us realize that it isn't.

By the way, the surgery went well and Bill is now slowly recovering.

President Art Nishimura called the meeting to order at 7:35 PM with opening gassho led by Rev. Matsumoto.

Minutes: Lucy Hamai made a clarification to the June 14 minutes. In her report on the BD Council Meeting, Lucy clarified that the future of the BD Buddhist Education Committee is being studied and not that of the Center for Buddhist Education. Judy Kono made a motion for the August minutes be accepted; motion seconded by Kiyoshi Katsumoto and passed.

Minister's Report: Rev. Upcoming events and activities include 9/14 BDMA Mtg. @ BBT; 9/18 Fall Ohigan/Keirokai Service and Luncheon @BBT; 9/22 Dinner with Mr. Toshihide Numata; 9/23 visit to BBT by Mr. Numata; 9/24-9/25 Senshin BT Fall Ohigan Seminar "Birth in Amida Buddha's Pure Land: & Service; 9/25 BBT DF & Shotsuki Memorial Service with Guest Speaker Rev. Kyonobu Kuwahara; 10/2 BBT Eitaikyo Service; 10/9 BBT DF Service.

Rev. Matsumoto reported that at the Fuken two nominees were put forth for Socho (Bishop)—Rev. Hanayama of Watsonville BT and Rev. Umezu of CBE. In October, the Selection Committee will make its choice.

Kiyoshi Katsumoto moved that the Board subsidize Edythe Vassell's MAP II registration fee; seconded by Lucy Hamai and passed.

Treasurer's Report: Satoshi Steimetz submitted a written report for 8/1-8/31/2011.

Eric Lindquist submitted a Reserve Fund written report dated 9/13/11. Eric recommended that the Board appoint more authorized signers for the Eitaikyo (Vanguard) Fund other than himself. Judy Kono moved that Kiyoshi Katsumoto and Satoshi Steimetz be appointed as two additional signers for the Eitaikyo Fund along with Eric Lindquist; seconded by Ron Hiraga and passed. Eric also recommended that the Board transfer more funds to the GNMA Fund and the TIP ETF Fund. Emiko Katsumoto moved that monies from the CBT account be moved to the reserve fund; seconded by Lucy Hamai and passed.

Correspondence: The correspondence binder was passed among the Board members. Information about the 11/5 BD Family Conference was discussed. Registration is \$50 for adults and \$30 for students, grades 1-5, with meals included. Lucy Hamai made a motion for the Temple to offer \$25 towards the registration of any adult BBT member who wishes to attend; seconded by Takashi Nikaidoh and passed. Dharma School will pay the registration of any DS student who attends the conference.

**RELIGIOUS COMMITTEE:** Rev. Pres. Nishimura will contact the Garden Comm. to see if the bench needs to be weather-proofed for outdoor placement.

**APARTMENTS:** Ron Hiraga reported that there was a reimbursement check from the Channing Way apts. He also summarized the Rent Board hearing re: tenant John’s complaint about inadequate sound-proofing and charges for parking as follows— 1) BBT was represented by Al Satake and John King of K&S and by Ron ; 2) established that the original rental contract did not include parking, so that issue was dropped; 3) agreement reached that the owners will add additional ceiling sound proofing for one room but will be allowed to raise the rent; 4) another hearing scheduled for 9/20 to formalize agreement.

**SCHOLARSHIP COMMITTEE:** Pres. Nishimura has sent the new scholarship criteria (see May 2011 minutes) to Helen Tagawa, and he will step down as temporary chair of this committee and appoint Wayne Sugihara as the committee chair.

**LIBRARY:** Emiko Katsumoto reported that with the completion of the Social Hall kitchen renovation a Library Committee should be formed to study the best permanent location for the Temple’s books. Emiko will ask members with library experience and training to serve on the committee.

**SATSUKI BAZAAR:** Kiyoshi Katsumoto presented a written report on the successful fund raiser.

**RUMMAGE SALE:** Emiko Katsumoto reported that the fund raiser netted \$5,700 and thanked all volunteers who worked many hours on the sale.

**TEMPLE SECURITY:** no report.

**CENTENNIAL:** Emiko Katsumoto reported that responses are coming in. Mr. Toshihide Numata, a generous benefactor to the BBT, will visit the Temple on September 23 for a service at 1:30 PM, followed by tea. Board members are invited to attend.

**NEW BUSINESS:** Dii Lewis would like to expand the outreach by Dharma School students and Jr. YBA to older Temple members. He will organize a committee to facilitate expanding youth dana.

Thank you to Doreen Buchholz and Russell and Amy Ware for providing the meeting refreshments.

Please feel free to ask any of our greeters for information. We are here to assist you with whatever level of participation you may be seeking.

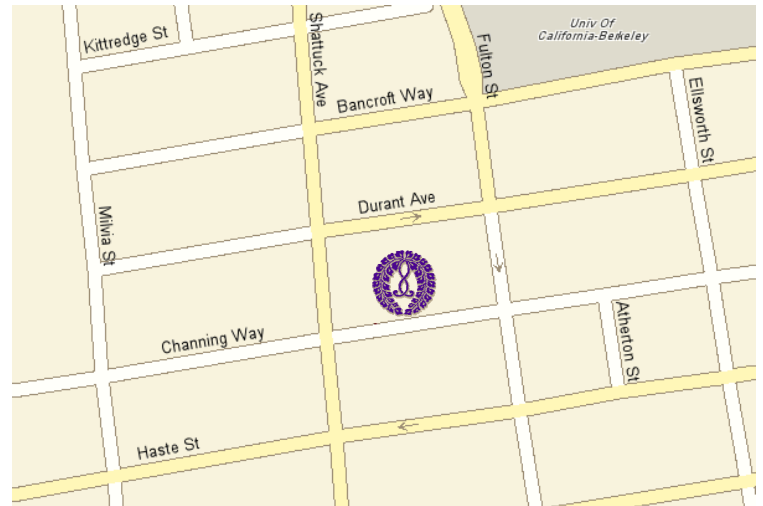
