The Treasure Mountain

Do not enter the treasure mountain and return with empty hands!

IN RECENT DAYS, I'VE BEEN FEELING MY AGE. My hair is getting whiter. My steps are slower. I keep losing my keys. Perhaps it's no coincidence that at this point in my life certain verses and songs seem to call out to me. For instance, here are some words from *The Essentials for Attaining Birth* (*Ōjō yōshū*) by the Pure Land Master Genshin (942-1017):

Frost and snow cover our heads. Our hearts are stained with worldly dust. Although our lives are about to end, our hopes and dreams do not. My wish for all is that you will not enter the treasure mountain and return with empty hands.

Time passes all too quickly. The young become the old; the healthy grow sick; and before we know it our hair is white as snow. And none of us go through life unscathed. We meet people we love and some that we hate. We face challenges and uncertainties. Sometimes we win and sometimes we fail. We develop habits, both good and bad. We store up memories and lessons, and we carry them with us throughout life

Yet even as we grow old and should be readying ourselves for the great change, we are still filled with wants, desires, and schemes. We dream of the big jackpot, the new car, the new body, or the new hair. For us, human life is a mountain of pleasures in which we try to get everything that we can, like kids in a candy store.

Genshin, indeed, teaches us that life is like a treasure mountain, for it is the place and time when we can hear the teachings of the Buddha and become liberated human beings. The true treasures in life are not material things. The true measure of a person's life is not in having the fastest car, the latest fashion or the biggest wallet. Rather, real treasure can be found in those conditions that allow us to hear the Dharma—the people that we love, joys and sorrows, our memories and dreams, and the timeless lessons that we receive from others. Through them and because of them we are able to hear the Dharma and share the Dharma with all other beings.

This poem by Mrs. Wariko Kai is a favorite of mine, for expresses this truth of life through the metaphor of a flowing river.

岩もあり	<i>Iwa mo ari</i>	<i>Though there may be rocks</i>
木の根もあれど	<i>Ko no ne mo aredo</i>	<i>As well as the roots of trees,</i>
さらさらと	<i>Sara sara to</i>	<i>It burbles, burbles;</i>
たださらさらと	<i>Tada sara sara to</i>	<i>It just burbles and burbles.</i>
水の流るる	<i>Mizu no nagaruru</i>	<i>River water flows and flows.</i>

From the peak of a mountain of treasures, a stream begins to flow. As it moves downward it joins with other streams, becoming a river that courses through valleys and plains. Its water flows over and around rocks and trees, picking up leaves, moss and dirt as it moves relentlessly on and on. The river of life flows on, but to where? To where? Its path is uncertain and constantly changing. Its destination, however, is not simply death, for the river has itself become a path of freedom from the bonds of birth-and-death.

Down from the treasure mountain river waters simply flow and flow until they break free from all hindrances and return at last to the ocean of Oneness—to the compassionate heart of the Buddha of unhindered light and infinite life. As we return to the Buddha's heart, may we be accompanied by the nembutsu—the precious and timeless treasure of the Dharma.

As we write this penultimate message a few days before Hoonko and week or so before Thanksgiving, we thought we would take this early opportunity on behalf of the board of directors at the BBT, to be among the first to wish everyone in the Berkeley Sangha a happy holiday season.

As Buddhists, it occurs to us that this is something of an ambivalent time of year. Over and above the most readily apparent juxtaposition of holidays and how we as Buddhists should or should not commemorate them, there are the seemingly contradictory orientations of personal and social demands. On the one hand, these last months of the year are the busiest, with a myriad of events and occasions. Every year it seems that the weeks and months go by much more quickly, and as such the year ends in a rush.

On the other, we are called upon by the same events and occasions to do the exact opposite. Most of the holidays during this time of year are intended to reflect on not only the passing year, but our lives and society in general. Moreover, throughout all of these activities, a running theme is that it is about being thankful and showing appreciation to those around us.

So what are we to do with this? Is this just an inherent contradiction or perhaps cruel irony in our lives? Are we destined to be so busy going through the rituals of being reflective and thankful that we don't have time to actually be reflective and thankful? Or is this all active practice of the Dharma? Do we practice the Dharma by the very activity of our lives, i.e., Christmas shopping as active meditation?

Thus, in the final word for now, this confluence of causes and conditions is perhaps only fitting as a regular and changing fixture in our lives. Just as the days get shorter and our schedules become fuller, we are simultaneously called to reflect and react both spontaneously and systematically at the same time. With such complexity and clarity required, what else can we do but be mindful and appreciative of it all?

October 9, 2012

President Art Nishimura called the meeting to order at 7:35PM with opening gassho led by Rev. Matsumoto.

September Minutes: Kiyoshi Katsumoto moved to accept the September minutes; seconded by Ron Hiraga and passed.

MINISTER'S REPORT: Rev. Katsuya Kusunoki, Lodi BC. Minister's Assistants Report: Sensei Matthew Hamasaki has returned from Japan having completed his Tokudo studies. Edythe Vassall was the 9/23 guest officiant and speaker @ BBT and took part in the MAP workshop. Tara Umemoto is now the youth minister's assistant.

Rev. Matsumoto reported on the Chapel of the Chimes community partnership program. Both the FAC and he recommend that the BBT join the partnership as it does not involve any financial or contractual obligation on the part of the BBT or its members. The partnership allows BBT members to purchase mortuary services at a discounted rate. Emiko Katsumoto moved that the BBT enter the community partnership program with Chapel of the Chimes; seconded by Wayne Sugihara and passed. Rev. Matsumoto will compose an information letter to the Temple members re: the partnership, which Chapel of the Chimes will mail to the membership along with a brochure on the mortuary's services.

TREASURER'S REPORT: Satoshi Steimetz issued a written report for the period 9/1 9/30/12. He notes that Bazaar funds were deposited into the operating fund in September and that any excess funds will be transferred from the operating account into investment accounts. Emiko and Kiyoshi Katsumoto asked the Board if the Centennial funds should be transferred to the general operating funds at this point, though there remain a few outstanding expenses. The Board recommended that this transfer be tabled to a later date.

CORRESPONDENCE: Art Nishimura passed the folder, noting that the Kaiser Community Giving Campaign inquired about a donation check to the Temple, which has yet to be cashed, and J SEI sent a thank you letter for the Temple's participation in the Family Festival.

BBWA: Yuki Otake reported the following: the FBWA Conference takes place October 12 14 in San Jose with Keynote speaker Evelyn Nakano Glenn and workshop speaker Edythe Vassall; for the 10/21 Eshinni/Kakushinni service the BBWA will serve a light lunch of sandwiches and salads; 11/18, following the Hoonko Service, the BBWA sushi/craft sale will take place and volunteers are needed for sushi preparation that Sunday around 8:30AM; the BBWA thanks the DS for putting together the gifts for the Keirokai guests.

DHARMA SCHOOL: Rev. Matsumoto reported that the DS service and Halloween party will take place on 10/27; 11/10 is the Temple Discovery Tour; for the April 2013 FDSTL Conference, the BBT DS will be in charge of the workshops. Art Nishimura noted that he has sent a new list of 2013 dates to the SFBC for the DS visit to the stupa and awaits a reply.

JR.YBA: Mali McGuire sent a written report, which included the following: open cabinet positions are now filled with Michael Adachi as Religious Chair and Tomi Lewis as BD Chapter Representative; DFS Chairperson Schedule 9/23 Mali McGuire, 10/7 Michael Adachi, 11/25 Maya Kato; 2013 chairperson dates will be assigned at the October 7 meeting; Events attended include 9/1 9/2 Fresno Mixer (Kiyoshi Din & Mali McGuire) and 9/8 BD Jr. YBA Meeting @ BBT (Mali McGuire); Future events include the 10/27 DS Halloween Party for which the Jr. YBA will create a Haunted House for the DS students, 10/7 the Community Service Committee (Michael Adachi, Tomi Lewis, Maya Kato) will discuss ideas, 10/7 Fundraising Committee (Celeste Furuya, Maya Haruyama, Maya Kato, Noel McGuire, Skye Nikaidoh) will discuss ideas, 10/7 BD Jr. YBA meeting @ Berkeley Otani.

J SEI: Yuki Otake reported on the letter sent by J SEI Executive Director Diane Wong which informed the BBT that the J SEI Advisory Board has entered an agreement to end formally J SEI's role in Eden Issei Terrace and thanks the BBT for its initial monetary donation of 30 years ago to fund the building, noting that any funds that J SEI receives from the agreement will be used to further the charitable mission of the agency.

APARTMENTS: Ron Hiraga reported that the vacant Channing Way apt. #3 has been rented. A reimbursement check was received from the Channing Way apartments.

OTHER REPORTS

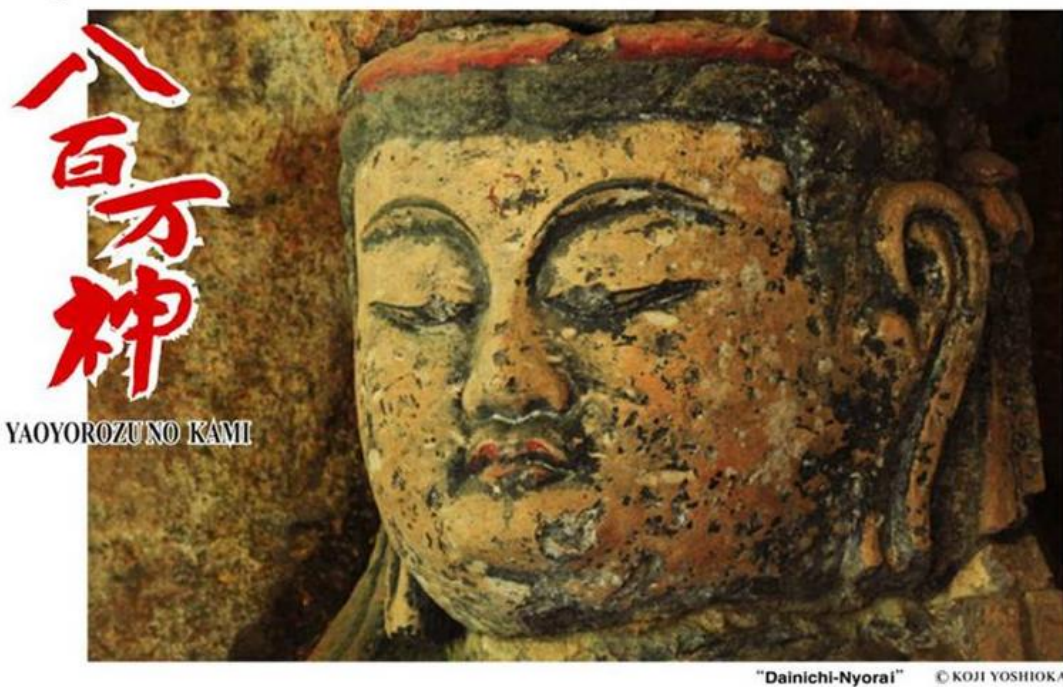

The Exhibit

In this exhibit, Koji Yoshioka will be coming from Japan to the United States to exhibit more than 20 photographs. The subject matter includes Buddhist icons and powerful landscapes. It is Yoshioka-san's hope that these images evoke a powerful, mystical and a spiritual feeling in the viewer.

About the Artist

Beginning in his childhood, Koji showed an interest in the natural world, especially in astronomy, which led him to observing the heavens. Through his astronomical observations, Koji learned photography, but then began to shift the targets through his lenses to objects on the ground, such as landscapes and people. He attended photography school in Tokyo, devoted himself to his studies, and emerged as a professional photographer.

While shooting pictures for advertisements, Koji took up documentary photography. He spent ten years photographing coal mining towns and their environs. In 1992, he was presented with the Newcomer's Award of the Photographic Society of Japan.

For his next project, Koji traveled all over Japan photographing esoteric mountain Buddhism and built his portfolio while practicing the discipline himself. In 1993, major publisher Shinchosha released the subsequent album entitled Mandala of the Mountain World. He was nominated for the Domon Ken Award.

Koji has deepened his meditations on the underpinnings of Japanese culture, and is currently intensely interested in the enduring reverence for nature exhibited by the Japanese people since ancient times and their concept of coexistence that respects the natural order and transcends simple animism.

With the assistance of photography and its power of presentation, Koji has totally committed to capturing human prayer and the spirit that dwells within every single tree and blade of grass.

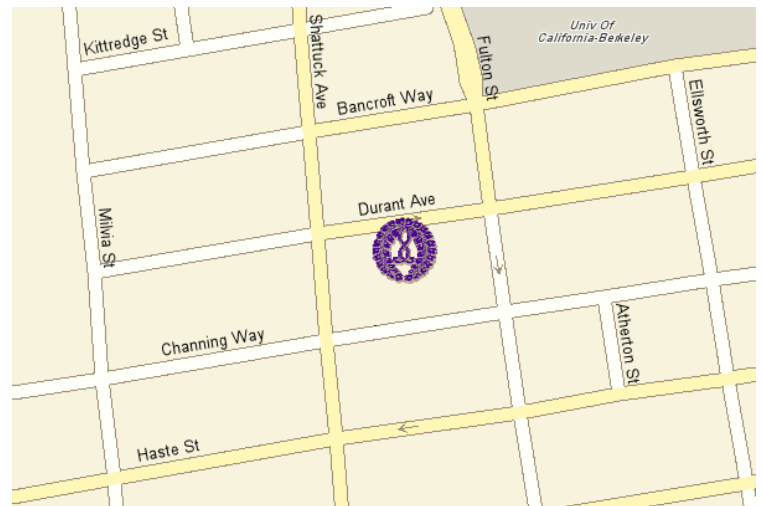
