We come together when conditions bring us to meet and part when conditions separate us.<sup>1</sup>

### AND SO ... WE MUST PART.

Echoing words from my first *Padma* article in January 2005, my family and I would like to express our deep thanks to you for allowing us to be part of this *nembutsu* community at the Berkeley Buddhist Temple for the past eleven years. We have been very happy here and grateful that we have been able to meet and get to know all of you over the years. We have enjoyed joining you as partners and friends in a “Dharmic enterprise” in which we all have had a stake and concern.

The words “goodbye” and “farewell” have a ring of finality about them. When we say them at a time of parting, there is a sense that our relationship is over or that we will never meet again. The Japanese word “*sayonara*” is often used with that same sense of “goodbye.” However, I believe that its meaning is much deeper. “*Sayonara*” (or more accurately, “*sayōnara*” さようなら) is derived from the classic phrase “*sayō naraba*” (左様ならば...). That expression can be understood to mean, “that being so,” “under those circumstances,” or “because of that situation.” I would state it more simply: “and so ...”

*Sayō naraba* recognizes that our lives—who we are and what we experience—are brought about through an infinite number of causes and conditions. This goes for the lives that we share with others. And when those conditions shift our lives change with them. In Shinran's words, “We come together when conditions bring us to meet and part when conditions separate us.”

Eleven years ago conditions brought us together at the Berkeley Buddhist Temple. They have allowed us to become friends, help each other and hear the Dharma together. But my work at the Institute of Buddhist Studies has increased of late, and it has become difficult for me to serve both IBS and our sangha adequately. “That being so” our paths must now diverge. Our temple will have a wonderful new minister in Rev. Candice Shibata, whom I am sure will be beloved by all of you. I will focus my attention on our school, its educational program, my students, and the future of Shin Buddhist Studies. And maybe, just maybe, I'll become a better husband and father.

And so ... we must part. Who knows where our paths will lead us? No one really knows. But we can be assured that with each step in our own journeys we will be together, embraced within the Dharma. I would like to end my last *Padma* article with these words from the first:

The Dharma of Jōdo Shinshū is based on this basic wish: that all beings may attain enlightenment. It is the wish that the disabled may be enabled—that the empty become fulfilled and the last become first. This is the fundamental wish of life. Life wishes to become itself so that all beings may know their true selves, become their true selves and live their true lives. This wish precedes all other wishes. It is the first aspiration of life, the Primal Vow of the Buddha.

And so ... first and last, our wish is that everyone at the Berkeley Buddhist Temple may be able to hear, learn and live the Dharma, and attain enlightenment together with all beings.

Thank you again for everything. *Sayōnara*.

## Who Am I? (Part Two)

Last month we started talking about the Buddhist teaching that the self is not what we think it is because it has no independent, permanent existence and is made up of parts. Specifically, we elaborated on what is meant by "made up of parts." Now let us address this idea that there is nothing permanent about the self, that, in other words, it constantly changes.

Am I still the cooing baby who was my mother's pride and joy or the moody teenager who was her cross to bear? I don't think so; neither of these people had gray hair or osteoarthritis. I'm also a lot larger than the infant and am able to get around by walking on two legs. However, the teenager could walk considerably longer distances without using a cane than I can now. All in all, I must conclude that I am neither the baby nor the adolescent, even though I am legally still the same person.

Of course I flatter myself that my mind has also changed and developed since babyhood and, indeed, since high school, that at the age of sixty-nine, I am more mature than I was at six months and, at times at least, more mature than I was at sixteen. But have I stopped changing? Not only has my physical form deteriorated with age, it continues to deteriorate at a frightening rate. As for my mind, well, what exactly is my mind? Is it my emotions? They change from hour to hour and sometimes from minute to minute, according to whether my body is functioning well or badly, whether I am reading a good book or cleaning the toilets, how well I am getting along with the people in my life, and too many other variables to list. Is it my thoughts? They go by even faster. They're rather like a rushing river, in fact. Even when I can pinpoint the thought I had in my head at some given moment, it's apt to be something like, "Do I dare to eat eggplant curry with my digestion in the state it's in lately?" I'd hate to think *that* constitutes my mind, much less that it's my essential self.

In short, before I can answer the question, "Who am I?" I have to ask, "Who am I at exactly what point in time?" My body changes faster than I like to think these days. (For instance, lately my digestive system may change for the worse almost immediately if I am rash enough to eat the eggplant curry.) My so-called mind cannot even be found amid the ever fluctuating chaos in my head. So where is the solid, permanent self I tend to assume I have?

## On Doubt

I was gratified to listen to Takashi Nikaidoh's sermon a few weeks ago where he spoke of his conversion to Jodo Shinshu beliefs. He spoke of his own Christian background as did our own Rev. Matsumoto in a recent sermon. I have in conversation asked this same question of other members of the Berkeley sangha and was comforted to discover that we have several ex-Christians like myself who have acknowledged Amida Buddha's vow. I joke about forming a Recovering Christian Support Group. Why, because I think there are at least two elements in Western Christianity that have caused me, and a lot of others, much anxiety and pain. One is the issue of sin and the other is of doubt.

The Christian concept of sin which, if it is not absolved through prayer and sincere repentance, reportedly can damn you to an eternity of pain and suffering. This is fairly easy to understand, but can cause tremendous psychological trauma in children and adults.

The other issue is doubt, which in Christianity has the same consequence associated with it. In other words, entertaining doubt is also a sin, and can likewise damn you. According to this thinking, you can forget about all the good deeds you've done in your life or your repentance for bad ones: if you have doubt you're out. Psychology teaches us that a person could, out of fear, suppress such thoughts, only to have them emerge as an emotional pathology.

Shinran Shonin spoke of keeping his faith in the Nembutsu even if his bones were crushed into dust. He speaks of his unwavering faith in Honen's teaching: "I have nothing to regret, even if I have been deceived by my teacher, and saying the Nembutsu should fall into hell". I'm sorry to admit that my faith is not that unshakably strong. As doubt surfaces, those Christian fears of burning in hell emerge: let's face it this is serious business.

The difference between sinful actions and doubt is that having doubt can be involuntary. It comes from our mind's reasoning ability, and often arises spontaneously. Occasional doubt in one's faith is something I'm sure we have all experienced, and I'm the first to admit to it. The concept of being punished for having doubt does not reflect the mercy Amida Buddha shows us bonbu who, because of our human nature and ignorance, are helpless against committing such "sins".

So, what does Jodo Shinshu say about how doubt affects our entry into the Pure Land? How do I accept my doubts and keep the faith? I think the answer is to be found in the Nembutsu and Jodo Shinshu teaching about our fallibility. We are unable to reach the Pure Land on our own self-power, namely jiriki. We must rely on the Amida Buddha, which is called other-power or tariki. To have doubts is a normal psychological function. As humans we can't escape them and therefore they cannot be "sins" because they can be involuntary. I truly envy those Shin Buddhists who were never traumatized as children when threatened with hell for thoughts that they had no control over.

Rev. Ikeda of New York City mentioned in his September seminar at the Jodo Shinshu Center that having doubts is normal for Buddhists (or for anyone else for that matter). And that in fact it can have a positive consequence, whereby doubt can initiate our interest in learning. What a beautiful and comforting way of looking at our doubts. Instead of the threat of some fearsome traumatic consequence, Jodo Shinshu teaches tolerance and understanding of our human weaknesses and encourages us to learn from them. The result is thus positive, allowing us to grow and solidify our beliefs. In conclusion I think we could look at doubt as a friend rather than an enemy to be feared.

Please feel free to ask any of our greeters for information. We are here to assist you with whatever level of participation you may be seeking.

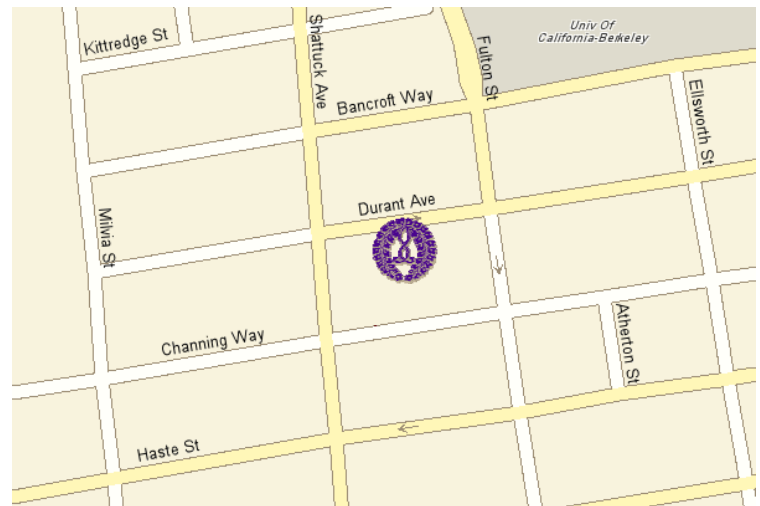
